| What is the overall deductible ? | Preferred providers \$1,000 individual/ \$2,000 family. | Are there services covered before you meet your deductible ? | Yes. Preventive care and primary care services are covered before you meet your deductible . | This plan covers some items and services even if you haven't yet met the deductible amount.
