Submit an [employer group admin registration form](#) to employerportal@geisinger.edu to start the enrollment process. Once the form is submitted and processed, the admin user will receive a registration email with login instructions.

2023 prescription drug reporting deadline nears for employer groups

The Consolidated Appropriation Act of 2021 requires insurance companies and employer-based health plans to submit information about prescription drug and health care spending to the Departments of Health and Human Services, Labor and Treasury.

We're asking employer groups enrolled in an Affordable Care Act (ACA), a "grandmothered" Keep Your Plan (KYP) or a Geisinger Funding Alternative (GFA) plan to provide required information that meets 2021 prescription data collection (RxDC) requirements by no later than Friday, April 12.

Remind your groups to complete the reporting form.
