### Fast facts:

- CMS released the [proposed 2023 Notice of Benefits and Payment Parameters](#) earlier this month. As usual, NAHU submitted [comments](#) to CMS with some questions and concerns regarding some substantial changes the agency recommended in the proposed rule.
- Supreme Court Justice Stephen Breyer officially announced this week that he plans to retire at the end of the current term, setting up the first Supreme Court nomination battle of Joe Biden's presidency.
- The U.S. Court of Appeals for the Second Circuit ruled this week that Medicare must provide appeal procedures for hospitalized beneficiaries who are reclassified from inpatient status to outpatient "observation status," a designation that can have serious consequences for seniors.
- On Jan. 25, OSHA [announced](#) that it was withdrawing the emergency final rule for vaccine requirements for large employers effective immediately. Does this mean the mandate is dead, or is the administration looking for a different legal pathway to implement the mandate?
