Group size certifications transitions to employer portals

The Affordable Care Act (ACA) requires health insurance carriers to follow regulations based on employer group size. We're excited to announce that group size certifications are now transitioning to the employer portal. Fully-insured, ACA, KYP and GFA groups with a registered employer portal admin will receive an email with instructions to complete their yearly certification through the employer portal.

When you log in, navigate to the plan administration tab and click on the designated blue "Group Size Certification" button to complete the online form. We'll send reminder emails on the 1st and 16th of each month until the group completes their annual certification.
